# 25<sup>TH</sup> AVENUE TRACK ALIGNMENT- ROSE MOFFORD SPORTS COMPLEX, SUN CIRCLE AND ARIZONA CANAL



During final design, the alignment of the Northwest Extension Phase II track location was shifted east on 25th Avenue at the Rose Mofford Sports Complex resulting in a decision to remove the proposed park-and-ride (shared parking) within the park's main parking lot. Removing the park-and-ride lot results in keeping the landscaped areas around the main parking lot in their present condition.

In addition, during final design it was determined that new, standalone light rail bridges over the Arizona Canal Diversion Channel (ACDC) and the Arizona Canal would be constructed to the east, impacting the Sun Circle and Arizona Canal trails.

These project changes result in impacts to Rose Mofford Sports Complex and the Sun Circle and Arizona Canal trails, all of which are protected by Section 4(f) of the US Department of Transportation Act of 1966.

#### DETAILED IMPACTS FROM PROJECT CHANGES

#### Rose Mofford

- Rose Mofford Sports Complex
- The light rail track alignment would be shifted approximately 10 feet to the east from the ACDC to Mountain View Road.
- The landscaping fronting 25th Avenue and adjacent to the softball fields would remain in its present condition.
- The project would acquire approximately 0.5 acres of landscaping area adjacent to 25th Avenue from the dog park parking lot and Mountain View Road. This is an increase of 0.28 acres from the previous design.
- Shifting the light rail track alignment east impacts an area of the dog park adjacent to the parking lot reducing the overall size of the dog park by 0.9 acres. The project would convert 0.9 acres of non-recreational area south and east of the existing dog park boundary to the dog park to compensate for the loss, restoring the dog park to its current size.

#### Sun Circle and Arizona Canal

• Twenty-one feet of the east side of each bridge will be removed and a new, standalone, 32-foot-wide light rail bridge will be

#### **Rose Mofford Sports Complex**

Since land from Rose Mofford Sports Complex would be converted for transportation use, there would be a direct use of this recreational property under Section 4(f). Shifting the light rail track alignment north of the dog park does not impact recreational amenities. Shifting the alignment on 25th Avenue adjacent to the dog park would directly impact 0.9 acres of the park. However, this loss would be replaced by adding 0.9 acres of non-recreational land (graveled area) back into the dog park resulting in no change to the size and function of the amenity. Therefore, the impact on the Rose Mofford Sports Complex would be "de minimis2," or minor.

#### Sun Circle and Arizona Canal


Since land from the trails would be converted into a transportation use, there would be a direct use of the trails under Section 4(f). After construction, the trails would be on the same, ground level alignment as they are today and would continue to function as they currently do; the only difference is that each trail would be negligibly shorter. Therefore, the use would be considered "de minimis," or minor.

constructed. Approximately 11 linear feet of the trails on the banks of the ACDC and Arizona Canal would be converted to a transportation project. This is a decrease of 32 linear feet from the previous design.

Phoenix Sky Harbor International Airport hosted a Farewell to Terminal 2 event on Tuesday, February 4. The event commemorated the Terminal which will close as the modernization of Terminal 3 is complete.

Terminal 2 opened in 1962, and it was Phoenix's gateway to the Jet Age. With 19 gates and 330,000 square feet of space, it was touted as one of the most modern facilities of its time. The Terminal also featured a large mural in the lobby titled "The Phoenix." This mixed-media mural, consisting of 52 different materials and created by artist Paul



#### I-17 IMPROVEMENTS BETWEEN ANTHEM WAY AND BLACK CANYON CITY

ADOT is planning to add third lanes in both directions on I-17 along the 15 miles between Anthem Way and Black Canyon City. The project will also improve traffic capacity along the eight-mile stretch south of Sunset Point Rest Area, by constructing an innovative system of flex lanes, a separate two-lane facility between Black Canyon City and Sunset Point. In addition to the I-17 general purpose lanes in that area, the two flex lanes will be available for drivers to use depending on traffic demand. Gate systems will be installed to allow only

direction of traffic to use the flex lanes at a certain time. For example, the flex will lanes be available for heavier northbound traffic on a Friday or made available for busy southbound traffic Sunday. on ADOT is preparing construct the improvements using the designbuild delivery method. Work will



include receiving proposals from joint ventures of design and construction contractors.

Construction is scheduled to begin in spring 2021 and is anticipated to be completed in 2023.



## **CITY MANAGER'S REPORT:**

## **Economic Development & Education**

On Jan. 9, Community and Economic Development staff conducted a pre-proposal meeting for the Mexico Trade Office Services Request for Proposals and had eight organizations register. Proposals are due today.

This week, Library staff hosted 381 attendees for STE/AM Programming which included viewing sci-fi movies, participating in creative art projects and building interesting designs using Legos©, K'nex ® and Snap Circuits®.

This week, Library staff hosted the Employer Engagement Series at the Harmon and Cholla Libraries. The Employer Engagement Series provides an opportunity to meet with prospective employers and learn about current job openings. This week's employers included: A Caring Heart and Washington Elementary School District.

On Feb. 13, Library staff will host a lecture by Dr. Bjorn Krondorfer at Burton Barr Library. Dr. Krondorfer will be sharing a personalized talk on the effects of the Holocaust and war on German society, family and German post-war generations.

Throughout February, the Volunteer Income Tax Assistance program will be available at Cesar Chavez, Cholla and Burton Barr Libraries. The program helps working families who earned less than \$56,000 in 2019 with free tax preparation and filing services.

From Jan. 30 to Feb. 6, the Phoenix Convention Center is hosted approximately 3,000 attendees for Avaya ENGAGE. Attendees attended sessions and informational breakouts led by some of the communication industry's most inspiring and accomplished leaders as well as learned about first-hand innovations in cloud communications and customer experience.

# Neighborhoods and Livability

On Jan. 16, Arts and Culture staff presented a Public Art Workshop at Burton Barr Library. Participants learned about designing perforated screens for bus shelters and how to apply for the Bus Shelter Shade Screen Art public art project. The deadline to apply for this project is Feb. 21.

This week, Sustainability staff submitted data for the national "Shining Cities" report that tracks solar growth in U.S. cities. Last year, the City ranked third and is expected to rank again with an 18 percent growth in the total capacity of solar.

This week, Environmental Programs staff provided technical assistance to Water staff during the Verde Water Treatment Plant removal of approximately 150,000 tons of arsenic impacted soils. The site has now been remediated to meet the Salt River Pima Maricopa Indian Community standards. Water staff are still in the process of backfill and site restoration.

This week, Planning and Development staff conducted a pre-application for the addition of a trailhead at the Tres Rios Recreation Area at 5610 S. 91st Avenue. The trailhead will provide picnic tables, a restroom, two ramadas, shade structures along the pedestrian path and parking spaces.

This week, Communications staff worked with Phoenix's chapter of the National Forum for Black Public Administrators to promote a series of events for Black History Month, culminating in an event at the Orpheum Theatre on Feb. 27. Staff developed a promotional push for the event including the program, promotional posters and graphics, and t-shirts for event attendees and participants.

## Neighborhoods and Livability

Recently, Planning and Development staff worked closely with the design teams and contractors for the major expansion of the Mayo Clinic at 5777 E. Mayo Boulevard. The project will nearly double the size of the existing campus over five years and is valued at \$648 million dollars. The construction project is expected to add 2,000 jobs by 2029 and is the largest expansion in its 30-year history in Arizona.

This week, Planning and Development staff gave preliminary site approval for the Polk Street Apartments, a proposed three story, 19-unit apartment development at 5300 E Polk Street. The building is to be constructed out of modular shipping containers.

This week, Planning and Development staff conducted a fact-finding meeting for Garfield and 6th, a new 26 story mixed-use development with associated site amenities at 813-821 N. 6th Street. A total of 309 residential units are proposed in addition to 6,946 square feet of commercial retail on the ground level to activate 6th Street.

This week, Planning and Development staff conducted a preliminary review meeting for Home2 TRU Hotel, a five-story hotel with 207 guest rooms and associated site amenities at 3110 N. Central Avenue. The hotel will be dual brand with 104 TRU guestrooms and 103 Home2 Suites. This development is part of the Park Central Mall revitalization that will activate a portion of Central Avenue.

On Jan. 29, Environmental Programs staff hosted the U.S. EPA Region 9 Administrator for a tour of the 5th Street and Buckeye brownfield project and of the Spaces of Opportunity brownfield project which both receive EPA funding assistance. The Buckeye project illustrates a collaborative effort to cleanup and redevelop ten acres for commerce park uses. The Spaces of Opportunity project is a community driven 20-acre urban farm, community garden, farmers market and arts and culture project and is one of the first Brownfields to Healthfields projects in Phoenix.

On Jan. 31, Environmental Programs, Equal Opportunity, Planning and Development and Light Rail staff met with the U.S. EPA Office of Environmental Justice Director for informal discussions and a tour of the Spaces of Opportunity project. The EPA is interested in learning more about the equitable community engagement work that staff has been conducting in South Phoenix and Maryvale as it relates to achieving the 2050 local food system goals.

# **Social Services Delivery**

On Jan. 24, a Police Recruit written exam was administered at Grand Canyon University to 56 applicants. Results were provided immediately following the exam and the 54 applicants that passed the written exam were invited to submit their AZPOST background packet. The next Police Recruit written exam is scheduled for Jan. 30 at Grand Canyon University. To date, 99 applicants have registered to take the exam. Additional exams are scheduled for Feb. 8, 21 and 28, and the job recruitments will remain open until the day of the exam.

From Jan. 23 to 24, Human Resources staff participated in the 2020 Maricopa County StandDown. This annual event is focused on providing services to veterans. Human Resources staff engaged and educated veterans on the City's application and hiring process.

This week, Human Services staff attended a meeting co-hosted by Arizona Coalition to End Sexual and Domestic Violence (ACESDV), Arizona Developmental Disabilities Planning Council, and Ability 360. The purpose was to foster collaborative relationships between sexual violence responders and organizations serving individuals with disabilities. The goal for the two historically-siloed movements is to learn from each other and create a community that supports the unique needs of sexual assault survivors with disabilities.

#### Infrastructure

This week, Public Transit staff worked with Valley Metro to promote light-rail related items including the newly launched app for the South Central/Downtown Hub project notifications, a construction recruiting and hiring event, construction notices and other milestones.

On Jan. 21, the 62nd HAWK was activated at the intersection of 70th Street and Thunderbird Road. This HAWK includes passive detection which was requested by members of the Jewish community to facilitate their path to and from the synagogues.

This week, Street Transportation staff sent out invitations for the Grand Canalscape Celebration on Feb. 15. Staff is working on the site plan as departments, outside organizations and retailers' express interest in having a table at the event.




#### WESD Community Food Drive Begins February 10
