
This flu vaccination service is in addition to the nocost COVID-19 tests already being offered by the city of Phoenix since May.

City of Phoenix Advocacy Center

The City of Phoenix Family Advocacy Center

(FAC) serves as one central location for victims of violence to receive a wide range of services. Through partnerships with community-based organizations and other city departments, the FAC provides comprehensive victim advocacy, counseling, case management, support groups forensic medical examinations, and investigative interviews.

The FAC's mission is to provide comprehensive services to victims of domestic and sexual violence, homicide, and other violent crimes; and to take a leadership role in educating the community about the impact of violence.



If you have been a victim of a crime, we are here to help. Crime victims of all types may experience trauma, which can be displayed in many ways.

Physical: Someone who has experienced physical trauma may have serious injury or shock to the body, as from a major accident. Intense stress reactions may also occur: Increase of breathing, blood pressure, and heart rate and muscles may tighten. Exhaustion, inability to sleep, headaches, increased or decreased appetites, or digestive problems may be a symptom of trauma.

Emotional: A crime victim may experience emotional trauma that may have long-lasting effects. Emotional trauma may take many different forms: Shock or numbness, denial, disbelief and anger.

Phoenix Selected to Host NCAA Women's Final Four in 2026



The NCAA has announced that Phoenix is the host city for the 2026 Women's Final Four. The national semifinals will begin on Friday, April 3, 2026 at Talking Stick Resort Arena with the national championship final game taking place on Sunday, April 5. This marks the first time that Phoenix has hosted the nation's top collegiate women's basketball championship, which has not been held in the west since 2012.

The Valley's bid was a collaborative effort, with the city of Phoenix, Visit Phoenix, the Phoenix Suns and Phoenix Mercury and Talking Stick Resort Arena teaming up with the Phoenix Local Organizing Committee and Arizona State University, which will serve as the collegiate host institution.

The 2026 Women's Final Four completes Arizona's resume as the nation's leading destination for major championships. The Valley will be the site of the 2023 Super Bowl and the 2024 NCAA Men's Final Four.

"The Phoenix Convention Center is proud to host the Women's Basketball Coaches Association (WBCA) National Convention and official fan activities for the Women's 2026 Final Four," said Phoenix Convention Center Director John Chan. "With over one million square feet of meeting and event space, convenient access to light rail and walking distance to Talking Stick Resort Arena and major convention hotels, and surrounded by numerous dining, retail, cultural and entertainment options, the Phoenix Convention Center is the perfect backdrop to create an inspiring event experience for more than 20,000 expected attendees."

Final Four events at the Phoenix Convention Center:

- Women's Coaches Convention the Women's Basketball Coaches Association (WBCA)
 Annual National Convention held in conjunction with the Women's Final Four will attract more than 2,000 coaches.
- Fan Festival is an interactive and educational fan event including competitions, basketball clinics, prizes, autograph sessions, special guest appearances, trivia contests, and entertainment.
- **Super Saturday Concert** is a free outdoor concert event held on the Saturday between the national semifinals and the national championship games.
- Youth Bounce is a family-friendly community event where children take to the streets in the downtown area, bouncing basketballs from a designated starting location and ending at the NCAA Fan Festival.

Downtown Phoenix is the premier event destination for all of the official 2026 NCAA Women's Final Four fan-related events, lodging and meeting activities associated with the tournament.

Registration Open for 2020 Phoenix Summit Challenge



Registration for the <u>2020 Phoenix Summit Challenge (PSC20)</u> opened earlier this week and spots are still available for those interested in participating.

PSC20 will feature a seven-day virtual opportunity for outdoor enthusiasts of all abilities to hike multiple summit trails throughout the city's preserve land. Changes needed to be made to this year's event due to the COVID-19 pandemic, but the spirit of the annual challenge lives on in this revised format. Participants will track their hikes by using the interactive online Walker Tracker application.

The dates of PSC20 are Saturday, Nov. 14 through Friday, Nov. 20. Registration costs \$30 and includes entrance into the event for one hiker, access to the Walker Tracker app and this year's <u>State Forty Eight</u> event t-shirt. <u>Register by visiting the PSC20 webpage</u>.

Trail list (to be completed in any order during the seven-day event):

- Ridgeback Trail at Apache Wash Trailhead (Sonoran Preserve)
- Dixie Mountain Summit Trail at Desert Vista Trailhead (Sonoran Preserve)
- Lookout Mountain Summit Trail 150 at Lookout Mountain (Phoenix Mountains Preserve)
- Shaw Butte Trail 306 at Shaw Butte / North Mountain Visitor Center (Phoenix Mountains Preserve)
- Alta East Trail at South Mountain Park/Preserve
- Holbert Trail at South Mountain Park/Preserve
- Pyramid Trail at South Mountain Park/Preserve

Participants can complete the seven suggested hikes or any other trails they choose. Those with mobility issues can choose to complete their steps on flatter terrain or even on a treadmill. The challenge will be complete once a pre-determined number of steps are accumulated. The steps translate into mileage which in turn add up to the total distance of the seven suggested hikes. Total mileage of the seven hikes adds up to 25.2 miles with an elevation gain of 5,230 feet.

This annual event helps to raise dedicated funding for the more than 41,000 acres of desert park and mountain preserve land located throughout Phoenix. City of Phoenix acts to Help Restaurant Owners Maximize Business while Following Safe Seating Requirements during COVID-19 Emergency



The Phoenix City Council approved the creation of Temporary Outdoor Dining and Alcohol Consumption Areas to allow restaurants to implement outside dining to accommodate their customers while meeting social distancing requirements and recommendations. The temporary outdoor dining program allows the Planning and Development Department to issue an "Emergency Declaration Temporary Outdoor Dining Administrative Temporary Use Permit" (ATUP) at no fee.

"Being responsive to businesses and their challenges during the pandemic has been a priority for the city and our staff," said Planning and Development Department Director Alan

Stephenson. "For the restaurants who need to reduce their indoor capacity for safety, outside offers an option to maximize the customers they can serve without compromising that safety."

Getting a use permit for outdoor dining can normally take between four to six weeks and requires a public hearing process. With the ATUP, staff will review the plans, within typically a 15-day time frame, and provide a temporary permit at no charge. The restaurant will not be required to have permanent fencing in place. Temporary enclosures will be permitted for areas serving alcohol to accommodate state requirements.

CITY MANAGER'S REPORT:

Economic Development & Education

Last week, various airlines announced they would resume flights to and from Phoenix Sky Harbor International Airport. On Oct. 8, Southwest Airlines resumed service to San José del Cabo International Airport in Cabo San Lucas and Licenciado Gustavo Díaz Ordaz International Airport in Puerto Vallarta. On Oct. 9, WestJet Airlines resumed service from Phoenix to Calgary International Airport. On Nov. 1, Hawaiian Airlines will resume non-stop service between Phoenix Sky Harbor International Airport and the Daniel K. Inouye International Airport in Honolulu.

From Oct. 13 through Oct. 23, the Sky Train will be shut down intermittently from the 44th Street Station through Terminal 3. Aviation staff is making necessary ride plate corrections near the Terminal 4 Station. The airport shuttle will be in service during these shutdowns to transport passengers and employees between stations.

During the week of Oct. 5, the Phoenix Families First Resource Centers hosted twelve virtual workshops focused on early language, literacy, child development, early learning, parenting and family stability. A total of 20 families, with children up to five-years-old, participated.

Since August, Arts and Culture staff have hosted 10 online capacity building workshops for more than 240 participants. Information on the current series of workshops, as well as recordings of past workshops, can be found on the Office of Arts and Culture website.

On Oct. 15, Arts and Culture staff presented "Public Art: Behind the Curtain," the second of five free online workshops this month. Artists Roberto Behar and Rosario Marquardt discussed their approach to developing public art projects. The workshops are open to all and take place every Thursday at 10 a.m. Those interested can register on the Office of Arts and Culture website.

Social Services Delivery

On Oct. 9, Housing staff, in partnership with the Area Agency on Aging, delivered 30 essential care supplies to Luke Krohn Senior Housing residents through the organization's Goods2Home Program. The care packages included home goods such as household cleaners, foil & plastic wrap, bleach, hand sanitizer, soap, shampoo, adult diapers, and pet food.

During the week of Oct. 5, Human Services staff conducted 2,027 wellness checks and delivered 609 meals to Senior center members.

To date, Library staff has provided curbside pickup services to more than 131,000 customers, with approximately 1.3 million physical library materials circulated by library cardholders.

This week, in partnership with St. Mary's Food Bank Alliance, Library staff served 796 meals to children and teens, ages 18 and under. The Kid's Café program is the result of a grant from the U.S. Department of Agriculture administered by the Arizona Department of Education. Meals are being provided Monday through Saturday during curbside pickup hours.

Public Safety

On Oct. 17, a Police Recruit written exam will be held at the Police Regional Academy. To date, 127 applicants have been invited to take the exam. Police recruitment remains open for applicants to register for written exams scheduled Oct. 29 and Nov. 6, as well as the ongoing online option.

Neighborhoods and Livability

During the week of Oct. 5, Parks and Recreation staff hosted four tournaments at sports complexes citywide, serving a total of 76 different teams. Staff hosted 463 allocations and 78 reservations on flat-land athletic fields citywide and scheduled 59 maintenance staff for 236 hours to conduct secondary cleaning on adjacent restrooms. During the week of Oct. 12, staff is currently scheduled to host 71 allocations and three tournaments at sports complexes so far.

This week, the draft Climate Action Framework was published for public comment. Office of Environmental Programs staff invites residents to provide feedback and comments on phoenix.gov/oep/cap through December. On Oct. 14, staff held a Climate Action Planning Virtual Workshop, which was open to the public. The workshop provided an overview of the framework with breakout sessions where participants could provide feedback and ideas in the areas of air quality, energy, heat, transportation, and waste.

Infrastructure

On Oct. 7, early ballots were mailed to voters on the Permanent Early Voting List (PEVL) for the upcoming City of Phoenix Mayor and City Council Election. Voters on the PEVL will automatically receive an early ballot by mail unless they submitted a request to not receive a ballot by mail.

Individuals who wish to vote in person rather than by mail can visit any voting site. Voting sites will be designated by the Maricopa County Elections Department and will be available beginning 27 days before the election, from Oct. 7 through Nov. 3, with hours of operation varying by location. On Election Day, Nov. 3, voting sites will be open to voters from 6 a.m. to 7 p.m. Voting site locations designated by Maricopa County can be found by visiting Locations.Maricopa.Vote or calling 602-506-1511. Voters are required to provide identification at in-person voting locations before receiving a ballot.

Public Transit staff is conducting outreach to inform transit riders travelling through downtown about upcoming bus service and bus stop location changes as a result of the Central Station redevelopment and South Central Light Rail and Downtown Hub projects. This outreach includes newsletters, a project website, billboards, digital signs at bus stops, social media, PHXTV, and other Valley Metro channels.

On Oct. 8, Street Transportation staff attended the Willo Board Virtual Meeting to present public feedback received and to discuss design decisions concerning pedestrian connectivity. Staff also shared information on the two-way cycle track on 3rd Avenue and the intersection design at 3rd Avenue and Encanto Boulevard. Speakers at the virtual meeting expressed a desire for continuous sidewalks on 5th Avenue from Encanto Boulevard to Thomas Road. This priority was echoed in the survey results, despite a few responses against sidewalks. Street Transportation staff will continue studying and providing cost estimates for two options to add sidewalks in this area.

On Oct. 12, 5th Avenue from Washington to Van Buren streets changed to two-way traffic with one lane in each direction. This change also allows a temporary bus route to use 5th Avenue in conjunction with the downtown light rail construction project. At this time, 5th Avenue north of Van Buren Street will remain a one-way southbound road but will be converted to two-way traffic with the street construction project. When completed, 3rd and 5th avenues will carry two-way traffic between Washington and Roosevelt streets.

This week, Street Transportation staff continue work locating existing utilities and surveying for the street improvement project from Roosevelt Street to Moreland Street, between 33rd Avenue and 34th Avenue. This project includes the installation of a sidewalk and curb ramps that are compliant with the Americans with Disabilities Act (ADA), installation and upgrades to streetlights, widening of 33rd Avenue between Roosevelt Street and Moreland Street and replacement of the existing private irrigation distribution ditch with an underground concrete pipe that will be underground. The project is scheduled to be completed in approximately four months.



COUNCIL DISTRICT 1 NEWS AND INITIATIVES

NORTHWEST EXTENSION PHASE II CONSTRUCTION UPDATE



The Northwest Extension Phase II project will extend light rail west on Dunlap Avenue from 19th Avenue, then north on 25th Avenue and across I-17 on Mountain View Road with a terminus on the west side of the freeway near Metrocenter Mall.

Northwest Extension Phase II light rail project construction is underway. The current work is exclusively third-party utility construction. The project contractor (Kiewit-McCarthy, A Joint Venture) will begin their work on Oct. 18.

- Dunlap Avenue between 23rd and 25th avenues (north side): Kiewit-McCarthy is performing underground utility relocation and roadway construction on the north side of Dunlap Avenue between 23rd and 25th avenues. Dunlap Avenue traffic will be restricted to one westbound and one eastbound lane daily. Traffic restrictions will be in place starting Sun., Oct. 18 at 7 a.m. through Fri., July 30, at 5:30 p.m. Click here [t.e2ma.net] for more information.
- Dunlap Avenue between C Street and 25th avenues (north side): Salt River Project is converting overhead electrical lines to underground facilities on the north side of Dunlap Avenue between C Street and 25th avenues. Westbound and Eastbound Dunlap Avenue will have one lane restricted daily. Traffic restrictions will be in place 9 a.m. through 4 p.m. through late December. PYRAMID PEAK WATER TREATMENT PLANT EXPANSION CONSTRUCTION CONTINUES FOR PHASE 2

Phase 2 expansion and improvements continue at Pyramid Peak Water Treatment Plant at various work zones.

CONSTRUCTION IMPACTS: Work is taking place primarily during daytime hours, weekdays; with some exceptions based on daytime temperatures or materials scheduling. All work and contractor areas are within the treatment plant property or public right-of-way.

- Increased truck traffic on Pyramid Peak Parkway may be observed through November as dirt-haul off takes place and concrete work nears completion. Concrete work may include intermittent early morning or night work with light equipment, as necessary.
- Lagoon pipeline and liner installation is complete and retention area mass excavation is nearing completion.
- Equipment installation for the Admin Building expansion and Chemical improvements has begun.

PROJECT OVERVIEW: When complete in Summer 2021, treatment capacity will increase to 54 million gallons per day and provide the ability to meet increasing service demand associated with area growth and development.



WESD Schools to Open in Hybrid Model Oct. 19

WESD schools will return to in-person instruction in a Hybrid A/B learning model on Monday, Oct. 19. These means that students will be divided into two learning groups – A and B. Students in the A group will attend school in-person on Mondays and Thursdays, while students in the B group will attend school in-person on



Tuesdays and Fridays. All students will participate in teacher-led Online Distance Learning on Wednesdays. On the days student are at home, they will log in to their Google Classrooms to complete required assignments and lessons. Additionally, the WESD is also offering an Online Learning model for families who wish to continue learning remotely.

The WESD is following the guidance from Arizona Department of Public Health Services and Maricopa County Department of Public Health. With current county metrics, the WESD falls into the Hybrid Learning Model. With students returning to school, the WESD will be using the recommended CDC and Maricopa County mitigation strategies including frequent hand washing and hand sanitizing, enhanced cleaning, proper ventilation, symptom screening, physical distancing and face coverings.
