

STREET TRANSPORTATION

Shared Streets for Social Distancing Pilot: City Seeks Applications to Add Safe Outdoor Recreational Spaces During Pandemic

Now through Dec. 31, Phoenix residents can nominate segments of their streets to be temporarily restricted to allow only local traffic, creating more space for outdoor recreational activities such as walking, running or biking while complying with public health and social distancing guidelines.



Residents must <u>submit an application</u> by 5 p.m. Dec. 31, 2020, to be considered for the pilot program. Residents may only submit applications for streets or street segments on which they reside. Program requirements include:

- Only <u>residential or minor collector streets</u> will be considered. Street segments cannot cross an arterial/major street or a signalized intersection.
- Street segments must be long enough to provide a meaningful opportunity for recreational activities (minimum of a half-mile).
- Street segments that contain loops are ideal, but not required.

The City of Phoenix Street Transportation Department will review all applications, prioritizing the following selection criteria:

- High population density areas with a greater need for recreational space.
- More than a half-mile distance from parks, trails or other public open spaces.
- Higher percentage of households without cars.
- Located within a previously identified Mobility Areas.
- Additional factors such as proximity to existing bicycle lanes, bus stops, libraries, schools, community centers and more.

The applicants of selected streets will be responsible for securing support from at least ten other residents along the proposed route. The Street Transportation Department will notify the nearby neighborhoods, install signage and barricades, and activate the shared street(s) for the pilot program in early 2021. City staff will evaluate the pilot locations including collecting resident comments, traffic counts, pedestrian counts and more. The pilot program is planned to be in place through May 2021 and more information is available at phoenix.gov/streets/shared.

Phoenix Completes Another Record-Breaking Street Paving Season



The city of Phoenix continues to pave more than ever before. The hottest summer on record and a global pandemic did not slow street maintenance crews and contractors who successfully completed the city's busiest paving season yet. These essential workers could not work from home, but with less traffic, pavement projects moved quickly and in a more convenient way.

Every year since its implementation in 2018, Phoenix's <u>Accelerated Pavement Maintenance Program</u> has broken records. 2019 marked Phoenix's largest paving season yet, tripling the number of major street miles paved than on average. And 2020 was even busier, with approximately 130 more miles of streets treated than in 2019.

Approximately 590 miles of Phoenix streets received pavement maintenance treatment in 2020 – about 12% of the city's entire street network.

The Accelerated Pavement Maintenance Program brings more benefits than smooth roads to Phoenix. People walking and riding bicycles will also notice improvements. A freshly paved street is a blank canvas – Street Transportation staff examine each roadway for opportunities to improve safety and bicycle connectivity. More than 40 miles of new bicycle lanes were installed and approximately 30 miles of bicycle lanes were upgraded to include buffers in fiscal year 2020. Additionally, more than 3,000 curb ramps were upgraded to meet the most current ADA standards through the 2020 pavement maintenance program.

"Phoenix residents chose to invest in their future by approving Transportation 2050 and we are fulfilling that choice by improving our city streets at a record-setting pace. Public safety, economic development and education all depend on properly paved streets and it is critical to do as much as we can during the paving season," said Councilwoman Thelda Williams, chair of the Transportation, Infrastructure and Innovation city council subcommittee. "We appreciate the patience of our residents while roads were restricted and the hard work of our staff and crews during this busy season."

The city of Phoenix also brought innovation to street maintenance in 2020 by introducing the <u>Cool Pavement Pilot Program</u>. Cool pavement was applied at nine locations across the city, covering 36 miles of residential streets in neighborhoods and one parking lot at a city park. This lighter in color asphalt treatment has the potential to offset rising nighttime temperatures in Phoenix, serving as "sunscreen for the road." The program, through a partnership with the city's Street Transportation Department and Office of Sustainability and Arizona State University researchers, will continue to be evaluated in 2021 to study the effectiveness and durability of the material.

The accelerated schedule for pavement maintenance continues through 2023. The city's interactive dashboard at phoenix.gov/pavement allows residents to see the program's completed projects and planned projects. The Accelerated Pavement Maintenance Program is a five-year program, funded through a Council-approved \$200 million advance on voter-approved Transportation 2050 revenues.


Northwest Extension Phase II Construction Update



The Northwest Extension Phase II (NWEII) project will extend light rail west on Dunlap Avenue from 19th Avenue, then north on 25th Avenue and across I-17 on Mountain View Road with a terminus on the west side of the freeway near Metrocenter Mall.

Northwest Extension Phase II light rail project construction is underway by the project contractor, Kiewit-McCarthy, A Joint Venture (KMJV) and third-party utility companies, such as Salt River Project (SRP).


• 25th Avenue between Dunlap Avenue and Mountain View Road: KJMV is performing underground utility relocation and roadway construction on 25th Avenue between Dunlap Avenue and Mountain View Road during day and nighttime hours. Traffic lanes will be located on the west side of 25th Avenue and restricted to one north- and one southbound lane. Traffic restrictions will be in place 24/7 through Fri., Jan. 29, 2021 at 5 a.m. Click here for more information.



• Dunlap Avenue between 19th and 25th avenues: KMJV and SRP are performing underground utility relocation and roadway construction on Dunlap Avenue between 19th and 25th avenues during day and nighttime hours. Traffic lanes will be located on the south side of Dunlap Avenue and restricted to one west-and one eastbound lane. Traffic restrictions will be in place 24/7 through Mon., May 31, 2021 at 5 a.m. Click here for more information



• Rose Mofford Sports Complex and Dog Park: KMJV is replacing drainage infrastructure in and adjacent to Rose Mofford Sports Complex and Dog Park. The work will involve removing fencing on the southwest corner of the dog park. Temporary fencing will be placed, allowing continued use of the park during construction. In addition, available parking areas will change throughout the process. The Rose Mofford Sports Complex and Dog Park will remain open during this work. The work will be completed in late spring 2021. Click here for more information.

CITY OF PHOENIX HAZARD MITIGATION PLAN

The city of Phoenix is requesting public input on the Hazard Mitigation plan that is in conjunction with the Maricopa County Hazard Mitigation Plan. The <u>Hazard Mitigation Plan</u> webpage is designed to obtain feedback on natural hazards you face and how better to prepare for them.

The Hazard Mitigation plan is updated every five years to keep up with changes in our city. This revision is important because it includes updates to the assets in our city, such as schools, museums, and city facilities, and how to protect them in the event of a disaster. Every major city department participates in the updates to the plan. This plan focuses on natural disasters. Natural hazards include dam failure, drought, extreme heat, fissures, flooding, severe winds, and wildfires.

During Fall of 2020, the city of Phoenix began revising the Hazard Mitigation Plan. According to Federal Emergency Management Agency (FEMA), hazard mitigation is any sustained action taken to reduce or eliminate the long-term risk to human life and property from hazards.

Here is where you come in! Input from the community is vital. Your experience in your neighborhood is likely different than someone else in another neighborhood across town. The feedback you provide is included in the new Hazard Mitigation plan and helps the city to be more prepared when faced with a natural hazard. When faced with a natural hazard, a more prepared community directly equates with money and lives saved.

- 3. Register your home safety camera systems, Ring doorbells, etc. with Phoenix Police Virtual Block Watch by texting "Join Today" to 555-888 or online at Phoenix Police Virtual Block Watch

Watch Out for Scams

- 1. Do not give or verify personal or financial information about you or anyone else over the phone to anyone you don't know personally
- 2. Government officials will never call your home asking for payment
- 3. Be wary of aggressive solicitors or panhandlers at your front door and NEVER invite them into your home
- 4. Consider posting a "NO SOLICITING" sign that is visible to anyone approaching your door


PUBLIC LIBRARY New Winter Curbside Hours

CITY MANAGER'S REPORT:

Economic Development & Education

On Dec. 3, Arts and Culture staff presented the fourth online workshop focused on law, business practices, and the arts, hosted by arts attorney Sarah Conley Odenkirk. The workshops are part of an ongoing artist professional development series that began in August. The free Thursday workshops have included 17 presentations by a wide range of artists. The workshops are taped and provided as permanent resources on POAC's web page. To date, more than 400 artists and arts professionals have participated

in the free webinars. Information and video links to completed workshops can be found on the Office of Arts and Culture website.

As of Dec. 4, Aviation staff reported 47 percent of businesses within Terminals 3 and 4 of Phoenix Sky Harbor International Airport remain temporarily closed. Within these terminals, 71 businesses, 53 percent, were open.

Aviation staff continues to promote COVID-19 testing at Phoenix Sky Harbor International Airport due to the COVID-19 pandemic. Staff organized additional signage, including directions and hours of operation, outside of the testing location and throughout Terminal 4.

On Dec. 2, the Terminal 2 demolition project at Sky Harbor International Airport began with the closure of the inner lanes in front of the terminal and restriction of a single eastbound traffic lane. Aviation staff has installed a chain-link fence around the demolition activity, concrete jersey barriers to reroute traffic lanes, and a protected walkway for passengers travelling to and from the West Economy Garage and the bus stop.

Construction on Phoenix Sky Train Stage 2 continues with roadway modification work along the closed west side of Copperhead Drive. Through Dec. 19, there will be roadway restrictions due to pavement placement. Additionally, landscaping and gabion basket installation is ongoing around the area of the I-10 Freeway off-ramp into the airport at the Copperhead Drive/Buckeye Road intersection.

Community and Economic Development staff has partnered with Downtown Phoenix, Inc. to create COVID-19 safe holiday celebrations in Downtown Phoenix, with several events and activations planned in collaboration with Herberger Theater, Ballet Arizona, Arizona Center, and others.

Social Services Delivery

To date, Library staff has provided curbside pickup services to more than 172,400 customers, with approximately 1,657,000 physical library materials circulated by library cardholders.

Last week, in partnership with St. Mary's Food Bank Alliance, Library staff served 681 meals to children and teens, ages 18 and under. The Kid's Café program is the result of a grant from the U.S. Department of Agriculture administered by the Arizona Department of Education. Meals are being provided, Monday through Saturday, during curbside pickup hours at select library branches.

During the week of Nov. 23, Human Services staff conducted 1,745 wellness checks and delivered 5,382 meals to 598 Senior Center members.

On Dec. 2, Housing staff hosted the first tablet distribution event for seniors at Fillmore Gardens and distributed 94 tablets. Residents also received a training manual, a reusable cloth mask, and two bottles of hand sanitizer. On Dec. 16, the next tablet distribution event will be held at Pine Towers. Housing staff purchased 800 tablets with 24 months of unlimited wi-fi access to provide senior public housing residents digital access to telemedicine, online services, and social media.

On Nov. 25, McCarty on Monroe was converted from public housing to Section 8 rental assistance through HUD's Rental Assistance Demonstration (RAD) program. McCarty on Monroe is an existing 69-unit affordable housing property for seniors. It is located at 1130 E. Monroe St. The property was redeveloped in 2010 with Low Income Housing Tax Credit equity and General Obligation Bonds from the City of Phoenix. By converting to RAD, the public housing units were converted to long term Section

8 based contracts which offer a higher rent and a more reliable funding source. Residents continue to pay 30 percent of their income towards rent.

On Dec. 7, construction began on Foothills Village, an existing 200-unit, affordable property converted through the HUD Rental Assistance Demonstration (RAD) program. Foothills Village will undergo an extensive rehabilitation that will include all 200 units, systems, grounds and the community building. Foothills Village is located at 920 W. Alta Vista Rd. The rehabilitation is financed with Low Income Housing Tax Credit equity, a private mortgage and gap financing from the City of Phoenix. Construction is expected to reach completion in October 2022. By converting to RAD, the public housing units were converted to long term Section 8 based contracts which offer a higher rent and a more reliable funding source. Residents continue to pay 30 percent of their income towards rent.

Public Safety

On Dec. 4, a Police Recruit Written Exam was administered at the Police Regional Academy. Results were provided immediately following the exam and the 23 applicants that passed the Written Exam were invited to submit their AZPOST background packet. Police recruitment remains open for applicants to register for a written exam scheduled Dec. 19 as well as the ongoing online option.

Neighborhoods and Livability

Effective Dec. 3, all athletic fields are closed, and Parks and Recreation staff have notified all organizers and groups with reservations.

On Dec. 15, Parks and Recreation staff, in partnership with the Hance Park Coalition and Fiesta Bowl Charities, will host a small ribbon-cutting event for the new Fiesta Bowl PLAY at Hance Park playground.

Infrastructure

Street Transportation staff is currently managing the installation of 42 streetlights in the area bounded by Lincoln Street and Watkins Street, from 7th Avenue to 3rd Street. This area, identified through the T2050 South Downtown Neighborhoods Mobility Study, was calculated to have the highest need in the city. The streetlights were among many mobility, accessibility, safety, and active transportation projects that were recommended by this Mobility Study. Staff has worked with the two qualified streetlight contractors since late 2019 to confirm their knowledge of City procedures for such installations and the value of this project is \$348,700.

On Dec. 2, Street Transportation staff held a design kickoff meeting to begin the installation of a pedestrian and bicycle path along the Western Canal between 4th Avenue and 24th Street. The pathway will include landscaping, lighting, and signalized crossings at local and major streets including Circular Rapid Flashing Beacons (CRFB), High Intensity Activated Crosswalks (HAWKS), and a traffic signal. Work design is scheduled to be completed by Fall 2021.

Street Transportation staff has completed construction and installation of a 10-foot concrete pathway to connect the Grand Canalscape to Glenrosa Park at 14th Street. The improvements include pathway lighting, landscape and irrigation, an ADA-compliant sidewalk and ramps, and micro seal.

This week, Street Transportation staff completed signal work at 10th Street and McDowell Road. The signal serves the Banner University Medical Center complex and will better serve their traffic demands.



All lanes open at I-17/Happy Valley Road Diverging Diamond: ADOT's reconstruction project provides room for future traffic needs

The new Diverging Diamond interchange at Interstate 17 and Happy Valley Road in north Phoenix is providing drivers with more lanes on a wider bridge that replaced an older, narrower crossing over the freeway, according to the Arizona Department of Transportation.

Work crews recently opened all lanes at the interchange after additional work to finish construction of the first major Diverging Diamond in Arizona. The interchange first opened to traffic in October while work continued to finish paving sections of lanes along Happy Valley Road.



The Diverging Diamond interchange design includes intersections and traffic signals that allow drivers to cross and travel on the left side of the new bridge over I-17. In the Diverging Diamond, which has grown in popularity in several other states, motorists make direct left turns onto the freeway on-ramps rather than waiting to turn in front of traffic traveling in the opposite direction.

The reconstruction project has more than doubled traffic capacity on the Happy Valley Road bridge. The on- and off-ramps at the interchange also are wider. There are fewer traffic-signal sequences and a reduced number of traffic conflict points. The Diverging Diamond design also improves traffic movement through the interchange. This past summer two roundabouts at the old interchange were removed to make room for the upgrades.

The improvements are part of a \$50 million project to reconstruct the I-17 interchanges at Happy Valley Road and Pinnacle Peak Road. I-17 also has been widened by one lane in each direction between Happy Valley and Pinnacle Peak roads. Work on the project started in November 2018.

Crews have been able to maintain traffic along Happy Valley Road during most of the interchange reconstruction.

Crews opened all lanes at the I-17 interchange at Pinnacle Peak Road in late November. It has been expanded as a traditional diamond interchange featuring more lanes and turn bays on the bridge over I-17. ADOT's project was funded as part of the Regional Transportation Plan approved by Maricopa County voters in 2004.
